Emissions reduction targets

As this is our first Carbon Footprint, we have adopted the following carbon reduction targets in order to make progress to achieving Net Zero.

We project that carbon emissions will decrease over the next five years to 9696 tCO₂e by 2028. This is a reduction of 15%.

Source Group is committed to achieving Net Zero by 2050, and as part of this commitment, has an interim target of reducing emissions by 15% by 2028. This plan is reviewed annually by the Directors to check progress and establish if changes should be made to the actions we have in place to maximise our reduction in carbon emissions.

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

We aim to achieve our Carbon Reduction goals by continuing to implement the following environmental management measures and projects:

- Selecting the most appropriate form of travel taking into account carbon emissions as well as other business factors and only travel when necessary
- Ensuring that our building is operated in such a manner as to optimise use and reduce emissions through control of heat and power
- Ensuring that the induction process for new people contains information about our Carbon Reduction policy and obligations to adhere to it
- Challenging behaviour of others who act in a manner contrary to the spirit of this policy
- Encouraging the powering-down of all appliances and lights when not in use, such as:
 - Turning off lights when leaving the room if not automated lights
 - Switch off mobile phone chargers when not in use
 - Switch off your monitor when not in use
 - Turn off your computer/laptop at the end of the day
- Providing online training packages to reduce paperwork
- Developed a Carbon Reduction Plan that is due for review in September 2024
- Reducing travel starting to adopt a hybrid flexible working schedule allowing employees to do a combination of working from him and working from the office reducing the amount of daily commuting
- Reducing consumption of paper, toner and stationery such as -
 - Only print if you need to
 - Print or photocopy on both sides of the page
 - Use a mug instead of single use cups for coffee and tea

In the future we hope to implement further permanent measures such as:

- Becoming fully paperless
- Promoting greener methods of travel
- Encouraging the use of remote company meetings to reduce business travel emissions
- Encouraging car sharing and public transport for any business travel that is inaccessible by foot/bicycle
- Replacing lighting for LED
